Revision in ATM Usage Charges

HIGHLIGHTS

- 1. ATM usage charges stand revised w.e.f. 15.06.2025
- 2. ATM usage charges beyond free limit will be Rs.23/- + GST (Financial Transaction) and Rs.9/- + GST (Non Financial Transaction)

Attention of Branches/Offices is invited to Debit Card policy 2025-26, circulated vide I.C.No.05507:2024-25 dated 25.03.2025, wherein service charges on ATM transactions were communicated as below;

Small/No frills/BSBDA customers will continue to enjoy Five free transactions at other ATMs at Metro Centres as well as Non-Metro Centres.

Bank is presently levying following charge beyond free ATM transactions;

- (A) Financial Transaction Rs.21/- excluding GST
- (B) Non Financial Transaction Rs.8/- excluding GST

RBI has issued circular no: RBI/2021-22/52 DPSS.CO.OD.No.S-182/06.07.011/2021-22 Dated: 10-06-2021, updated as on 28-03-2025. Beyond the free transactions, a customer may be charged a maximum fee of Rs.23/- per transaction. Accordingly, competent authority has approved the revision in ATM transaction charges beyond free limit as below;

- (A) Financial Transaction Rs.23/- excluding GST
- (B) Non Financial Transaction Rs.9/- excluding GST

The revised charges will also apply, *mutatis mutandis*, to transaction done at Cash Recycler Machines (other than for cash deposit transactions).

The above revision is not applicable for Micro-ATM, Interoperable cash deposit (Card based & UPI based) and international ATM transactions and it shall continue to remain same as per the existing rate.

<u>Notice to Customers</u>: Branches are advised to invariably put up a Notice (Annexure-A) effecting the changes of said revision in the customer approach area/banking hall/notice board/ATM premises.
